Key Findings

- Alliance Advisors analyzed 13F filings of 17 key activist investors. Our analysis focused on US-listed companies only.
- □ Top 3 sectors with largest activist holdings are:
 - Industrial
 - Consumer/Retail
 - Technology
- □ Of the 306 U.S. companies owned by the activists 60% are small/mid-cap.
- Alliance Advisors' proprietary Board Risk Score ("BRS") model an early warning system that assesses vulnerability to activist attack - accurately identified <u>81%</u> of activists' positions as either Medium or High risk as of 12/31/2015.




Industrials Sector Has the Highest Activist Investment

Board Risk Score[™] (BRS)

"Who is the next target?" "Is there a way to measure activist risk?"

- BRS is a quantitative scoring methodology that assesses a company's vulnerability to activist attack. During 1H2016, <u>92%</u> of Russell 3000 companies (non-financials) - where activist sought board representation – were rated as either High or Medium Risk by the BRS model.
- It is an early-warning system which provides an objective and independent analysis of a company's performance – the same analysis used by most activist investors in identifying and targeting public companies.
- BRS enables companies/boards to know if they are appearing as potential targets on activist screens.
- The model was developed by Waheed Hassan, CFA, along with along with two PhDs. Prior to joining Alliance, Waheed managed the Proxy Contest research team at ISS, where he was involved in over 100 contested meetings including proxy fights at Target, Office Depot, and NRG Energy.





BRS Distribution for Companies with Activist Holdings






Sectors With Highest Activist Investment* Have the Most Vulnerable Companies (High/Medium Risk)
